Under the strategic objective of better protection of the society, Mr. Das supervises the work articulated around risk management, revenue fraud, passenger control and SAFE, antimoney laundering and counter-terrorism financing, and drugs and medicines.

Prior to joining the WCO Mr. Das has been working as a Chairman of the Central Board of Indirect Taxes and Customs in India, promoting customs reforms in India and supporting multiple initiatives for easing traffic and transit in India's land-linked neighbors, which led to significant reduction in dwell time and costs for traders.

## James McColm

Jim has been the Acting Deputy Director of Compliance & Enforcement at the World Customs Organization (WCO) since September 2023, with responsibility for 8 enforcement and compliance work areas, covering Anti-Money Laundering, Drugs, Revenue, IPR, Environment, and Security Programme as well as responsibility for Enforcement related IT, targeting and risk management system and expertise.

Prior to this he was a Senior Technical Office at the WCO for 7.5 years and the Programme Manager of the WCO's Security Programme, being responsible for the delivery of the WCO's Strategic Trade Control Enforcement Programme along with Programme Global Shield (Counter-IED precursors and components), the Small Arms and Light Weapons Project, and Radiological Nuclear (RN) Detection Awareness Training, as well as a number of regional focused security projects in SE Asia, Africa, the Middle East and the Caribbean.

Jim has over 30 years of Customs Experience. Previous to his time at the WCO, he worked for HM Customs & Excise (HMCE) and Border Force in the UK. During that time he worked in both Intelligence and Detection operational and management roles, spending 10 years in National Intelligence as a Strategic Intelligence Analyst and Intelligence Manager and 8 years at Heathrow Airport as the Senior operational Manager of Freight Anti-Smuggling, with national responsibilities for Counter-proliferation and Counter-terrorism.

Jim was also the first Customs' Liaison Officer to the UK's Joint Terrorism Analysis Centre (JTAC) where he worked with Police and Intelligence agencies on border related international terrorism developing training, briefing material and packages for frontline Customs staff. He also established and led the Border Force Counter Proliferation Team,

modernizing and professionalizing Border Force's approach to risk based export controls, leading to a large increase in proliferation related seizures between 2012-2016.
