VIII. Fighting international Bribery and Illicit financial flows (IFFs)

(a) Fighting International bribery- the OECD perspective

A representative from the OECD will address the issue highlighting aspects of how to fight International bribery and the role of Customs in this perspective including how Illicit financial flows can be controlled and risks mitigated. The OECD advocates for fighting bribery in international business in order to strengthen development, reduce poverty and bolster confidence in markets. The keystone to its efforts is the OECD Anti-Bribery Convention and the Convention's 2009 Anti-Bribery Recommendation.

(b) It takes two to tango – new Private sector initiatives to prevent Bribery when interacting with Customs

A private sector organization will share its experience in preventing misconduct of their own staff in dealing with Customs officers including practical measures taken in collaboration with Customs to prevent corrupt behavior.

(c) WCO initiatives and tools to curb illicit financial flows (IFF)

The WCO Secretariat will present initiatives and tools that aim to support efforts to prevention and fight IFF and the areas in which Members seem to require assistance based on WCO experience. The content of the WCO Action Plan on IFFs and stages of its implementation will also be presented. This will also be an opportunity for Members to express from an anti-corruption viewpoint their expectations from the WCO in terms of support in fighting IFF.
